### Comments:

Outside food and drink will be allowed ONLY in the hallways, not in the arena. Items with outside heating sources like crock-pots, Foreman grills, etc are not allowed due to potential fire hazards. There will be a small concession stand with drinks and snacks, but we do not serve lunch items since we allow you to bring outside food.

Bleacher seating is limited on some courts, so we encourage you to bring your own chairs. We do ask that you bring a blanket or something to put underneath the chair though to protect our arena floor. No metal legs will be allowed on the floor.

8 team tournament: 2 pools of 4 will play a single round robin consisting of 2 sets to 25 points starting at 4-4. All teams will advance to single elimination playoffs and awards will be given to the 1<sup>st</sup> and 2<sup>nd</sup> place teams.

10 team tournament: 2 pools of 5 will play a single round robin consisting of 2 sets to 25 starting at 4-4. This will actually be played on 3 courts to speed things up. **Please note that the schedule below is not the official schedule for 3 courts! Official schedule will be emailed to team reps!** Top 3 teams from each pool will advance to a single elimination playoff and awards will be given to the 1<sup>st</sup> and 2<sup>nd</sup> place teams.
